In consideration of being permitted to use the facilities at Ski Shawnee, Inc. (d/b/a Shawnee Mountain Ski Area), and participate in the competition covered by this registration and agreement, I expressly acknowledge and agree:

1. I am physically fit and possess the physical strength to meet my responsibilities as a skier or snowboarder and state that I will not participate in the sport of skiing or snowboarding while under the influence of drugs or alcohol;
2. I agree to observe, read and abide by any and all notices as may be posted from time to time by the management of Ski Shawnee, Inc. which may pertain to my responsibility as a skier or snowboarder;
3. I, the undersigned, know that Alpine Skiing and Snowboarding carry significant risk of personal injury. Racing or Freestyle competition is even more dangerous;
4. Alpine or Nordic Skiing and Snowboarding, including the use of lifts is a dangerous sport with inherent and other risks. These risks include, but are not limited to variations in snow, steepness and terrain, trail side drop-offs, ice and icy conditions, moguls, rocks, trees, and other forms of forest growth or debris (above or below the surface), bare spots, lift towers, utility lines, poles and guy wires, snowmaking equipment and component parts, trail fences and the absence of such fences and other forms of natural or man-made obstacles on and/or off designated trails, as well as collisions with equipment, obstacles or other skiers or snowboarders. Trail conditions vary constantly because of weather changes and skier or snowboarder use. These are some of the risks of skiing and snowboarding. All of the inherent and other risks of skiing and snowboarding present the risk of serious and/or fatal injury.

In consideration of using Ski Shawnee, Inc.'s facilities, the purchaser or user of this ticket agrees to accept the risks of skiing, snowboarding and snow tubing and agrees not to sue Ski Shawnee, Inc. or its employees if hurt while using the facilities regardless of any negligence, recklessness or any other improper conduct of Ski Shawnee, Inc. or its employees or agents.

I agree that all disputes arising under this contract and/or from my use of the facilities at Shawnee Mountain shall be litigated exclusively in the Court of Common Pleas of Monroe County or in the United States District Court for the Middle District of Pennsylvania.

5. The Registrant covenants not to sue the owner, and any other sponsors or agents, from any liability arising out of personal injury wherein the personal injury was the result of an activity conducted as part of the usual activity of the owner. The owner assumes no responsibility for activities undertaken by the Registrant without proper supervision and guidance;
6. I hereby expressly acknowledge my understanding and acceptance of the foregoing and agree to assume the risk of any personal injuries, which I may incur during my use of the Ski Shawnee, Inc. facilities;
7. I agree not to sue Ski Shawnee, Inc. , or any competition sponsors, or the employee or agent of them, if I am injured or incur injuries resulting in my death, when preparing or practicing for the competition, and/or become injured in any manner arising out of the competition;
8. I agree that I grant permission to Ski Shawnee, Inc. to utilize any photograph, video, tape, motion picture, recording or other record of my use of its facilities for any legitimate purpose.
