In consideration of being permitted to use the facilities at Ski Shawnee, Inc. (d/b/a Shawnee Mountain Ski Area), and participate in the competition covered by this registration and release agreement, I expressly acknowledge and agree:

I am physically fit and possess the physical strength to meet my responsibilities as a skier or snowboarder and state that I will not participate in the sport of skiing or snowboarding while under the influence of drugs or alcohol. I agree to observe, read and abide by any and all notices as may be posted from time to time by the management Ski Shawnee, Inc. which may pertain to my responsibility as a skier or snowboarder. I, the undersigned know that Alpine skiing and Snowboarding carry significant risks of personal injury. Racing, Freestyle and Big Air Competitions carry a far greater risk of personal injury and are significantly more dangerous.

The competitor or user agrees and understands skiing, snowboarding, and other on-snow sports, including the use of lifts are dangerous sports with inherent and other risks. These risks include but are not limited to, variations in snow, steepness and terrain, trail side drop-offs, ice and icy conditions, moguls, rocks, trees and other forms of forest growth or debris (above or below the surface), bare spots, lift towers, utility lines, poles and guy wires, snowmaking equipment and component parts, trail fences and control nets and the absence of such fences and nets, and other forms of natural or man-made obstacles on and/or off designated trails, as well as collisions with equipment, vehicles, obstacles or other participants, trail conditions vary constantly because of weather changes and skier use. These are some of the risks of skiing and snowboarding. All of the inherent and other risks of skiing and snowboarding present the risks of serious and/or fatal injury. Always stay in control.

**IN CONSIDERATION OF USING SKI SHAWNEE, INC.'S FACILITIES, THE PURCHASER OR USER OF THIS TICKET AGREES TO ACCEPT THE RISKS OF SKIING AND SNOWBOARDING AND AGREES NOT TO SUE SKI SHAWNEE, INC., ITS AGENTS OR ITS EMPLOYEES IF HURT WHILE PARTICIPATING IN THE LITTLE BIG AIR COMPETITION OR USING THE FACILITIES EVEN IF I OR THE USER CONTENDS THAT SUCH INJURIES ARE THE RESULT OF NEGLIGENCE, INCLUDING GROSS NEGLIGENCE OR ANY OTHER IMPROPER CONDUCT FOR WHICH A RELEASE IS NOT CONTRARY TO PUBLIC POLICY, ON THE PART OF SKI SHAWNEE, INC., ITS AGENTS OR EMPLOYEES.**

**I agree that all disputes arising under this contract and/or from my use of the facilities at Shawnee Mountain shall be litigated exclusively in the Court of Common Pleas of Monroe County or in the United States District Court for the Middle District of Pennsylvania. The Purchaser or user of this ticket voluntarily assumes the risk of injury while participating in the sport.**

I agree that I will indemnify and defend Ski Shawnee, Inc. from any loss, liability or damage or cost of any kind that may incur as a result of any injury to myself, my child or any person for whom I am signing this agreement, even if I contend that such injuries are the result of negligence, including gross negligence, or any other improper conduct for which a release is not contrary to public policy, on the part of Ski Shawnee, Inc.

I hereby acknowledge my understanding and acceptance of the foregoing and agree to assume the risk or any personal injuries which I may incur during the Little Big Air Competition or my use of Ski Shawnee, Inc.'s facilities.

I agree not to sue Ski Shawnee, Inc., any competition sponsors, or the employees or agents thereof if I am injured or incur injuries that may result in my death, when practicing or preparing for the Little Big Air Competition and/or become injured in any manner arising out of my participation in the competition.

I agree that I grant permission to Ski Shawnee, Inc. to utilize any photographs, video tapes, motion pictures, recordings or other record of its facilities for any marketing purposes such as, but not limited to brochures, websites, facebook and other social media.
