4. How to Enter: The photo must be posted on Instagram using the hashtag #myshawnee. The entry must fulfill all Campaign requirements, as specified, to be eligible to win a prize. Entries that are incomplete or do not adhere to the rules or specifications may be disqualified at the sole discretion of Shawnee Mountain Ski Area.
